Friday, Aug 12 8:00AM - 11:30AM	Cross-Sector Partnerships for Social Innovation: Processes, Perspectives and Positioning Building on these previous PDWs, this year we focus on shaping and disciplining the scholarly conversation about cross-sector partnerships. During the previous PDWs, a number of themes have emerged that relate directly to this year's theme: West meets East: Enlightening, Balancing, and Transcending. This PDW proposal organizes these themes into a deeper discussion about the processes, perspectives and positioning of social innovation; we focus on cross-sector partnerships because they are living laboratories for social innovation within and across sectors. Our focus is three-fold: we address processes that can engender (more) balanced development of people and products, often through reengineering of markets as well as non-market strategies. We also consider how additional theoretical perspectives can enrich our conceptualization of social innovation, welcoming additional contributions from critical management and positive organizational scholars. Last, we aim for an enlightened platform for scholarly work in cross-sector partnerships by harnessing this discussion to collectively brainstorm about the positioning of this emerging field. Friday, Aug 12 12:30PM - 2:30PM	Captains of Lives - Transformation of Singapore Prison Service This PDW is about a unique a real-life example of organizational change in the context where most people would least expect inspirational leadership: Singapore prison service underwent a remarkable transformation journey to become not only an example for successful new prison management but also successful in terms the positive impact on the society of the country. In this workshop we will showcase the real-life story and explore ways how to use it in teaching in executive education. The workshop will be run in collaboration with a practitioner, (the ex-director of Singapore Prison Service), and 2 academics who use the story in teaching and research. The workshop relates directly to the conference theme "West meets East" as it demonstrates a case of modern management in an Asian public service.	Marriott Riverwalk in Salon D
Saturday, Aug 13 8:00AM - 10:00AM	A Quality Improvement Model that Works for the Public and NonProfit Sectors  This workshop proposes to teach Academy of Management participants about a QI model called NIATx that is designed specifically for public and nonprofit organizations. The model was first employed in addiction treatment and has been extended to other human service settings such as aging, veteran services, HIV/AIDS, criminal justice, adolescents, mental health, Native American populations, and disabilities. For this professional development workshop, expert faculty from the University of Wisconsin-Madison will provide training on the NIATx QI model. Saturday, Aug 13 8:00AM - 2:00PM	Executive Interaction, Tour, and Volunteering at Haven for Hope Haven for Hope is a new, standard-setting homeless transition center located near downtown San Antonio. Opened in 2010, Haven for Hope represents a partnership among local business leaders, city leaders, state and county governments, and approximately 78 social work organizations, and it addresses the root causes of homelessness. The facility serves approximately 1,600 men, women, and children at its 37 acre, \$100 million campus. The Local Arrangements Committee worked with Haven for Hope's staff to schedule an executive interaction, campus tour, and volunteer opportunities for attendees of the Academy of Management 2011 Annual Meeting. It is believed that AOM members will develop a deeper understanding of the challenges faced by non- profit managers in starting and running such highly complex organizations through these activities. Participants depart from the Convention Center at 8:00 am on Saturday, August 13, 2011 (transportation provided). A tour of the Haven for Hope campus occurs from 8:30 am until 9:30 am. Following the tour, participants will hear from Meghan Oswold, VP of Development and Communications at Haven for Hope, who will speak about the challenges of starting and running such a complex organization. Then, participants will have the option to volunteer in the San Antonio Food Bank that is housed on the campus, work in the Prospects Courtyard Kitchen, or complete miscellaneous tasks around the campus. Saturday, Aug 13 8:00AM - 11:00AM	Managing Change in the Aftermath of Extreme Events Following the success of this Workshop theme in 2009 and 2010, we will this year explore in greater depth the practical, theoretical, methodological, and pedagogical challenges in managing change in extreme contexts. This year there is a clear shift to the generation of a relatively small number of empirically-based case studies. We will focus on the conditions and processes that respectively encourage and inhibit change in the aftermath of such events, leading to developments in theoretical understanding, and guidelines for organization and management practice. One overarching aim is to bridge scholarship from separate but related fields: normal accidents, high reliability organizations, risk and crisis management, sensemaking in crises, the role of public enquiries, and change management. A second aim is to maintain an international network, to progress the research agenda, and to develop a contingency framework for managing change in extreme contexts. Saturday, Aug 13 8:30AM - 12:00PM	Social Entrepreneurship and Broader Theories: Shedding New Light on the "Bigger Picture"  Social entrepreneurship is now a dynamic field of research. However, although many see social entrepreneurship as an important element in the "bigger picture" of societal organization, much of the research to date takes an actor-centered perspective, focusing, e.g., on the individual motivations of social entrepreneurs. This is certainly important, but we feel that it is promising to combine an actor-centered perspective with more system-oriented theories on society's "bigger picture" and the role of social entrepreneurship in it. The key idea of this workshop is to link social entrepreneurship research with more established theories on the economic, social, and political organization of society. Pecha Kucha presentations, a format forcing the presenters to be concise and to the point, will serve to introduce alternative theoretical paradigms and potential linkages to social entrepreneurship. We will also provide room for plenary debate and allow the participants to engage in small-group discussions. We want to organize an inspiring and interactive workshop. All the organizers were involved in last year's PDW on "Social Entrepreneurship: Future Directions in Education and Research" either as organizers or active participants. The PDW attracted many interested scholars from around the world and led to interesting discussion. We hope that this year's workshop will similarly inspire social entrepreneurship researchers and academics from "neighboring" disciplines. Although the primary workshop sponsor is the ENT division, we strongly believe that the workshop will be beneficial to scholars from other fields.  Pre-registration is required for this workshop.
