The Journal of Public Administration Research and Theory (JPART) will give a plaque and a \$50 Amazon gift card in recognition of each of the top ten reviewers of conference paper submissions to the Public and Nonprofit Division of the Academy of Management Annual Meeting (AOM-PNP).

Winners will be based on the ratings from AOM-PNP's reviewer ratings process, identified by the AOM-PNP Program Chair, confirmed by the JPART Editor, and recognized at the PNP Business Meeting.

Reviews will be judged based on the information and guidelines provided by the Academy of Management, below. To reiterate these standards, we seek reviewers who:

AOM-PNP conference paper reviewers who are members of PNP will automatically be considered for the award. Three of the ten awards will be reserved for doctoral student members of PNP. PNP members are limited to one award every other year.

All reviewers have received a reviewer certificate as appreciation for their service.
