All of these endeavors ought to help us to take a step back and really look at our Division and its operations. I expect that we will find good things in our investigation.

2012 Academy of Management Annual Meeting August 3 - 7, 2012 Boston, Massachusetts

If you are a doctoral student with aspirations to research and teach in public or nonprofit management, consider applying to the Doctoral Student Professional Development Consortium of the Public and Nonprofit (PNP) Division of the Academy of Management (AoM). The Doctoral Consortium is an unparalleled opportunity to (a) get tips on finding an academic job; (b) present your existing research or proposal and obtain feedback from senior scholars; and (c) network among peers, future colleagues, and potential employers. The Doctoral Consortium takes place on Saturday, August 4, 2012.

This call is an advance call to enable you to be listed in the AoM Meeting program. If you are interested in attending the Doctoral Consortium, please consider submitting a one to three page research proposal or abstract of a research paper by February 3, 2012 by 5:00pm ET. If you have decided on a dissertation topic, submit a short synopsis of the dissertation. If you have not yet articulated a dissertation topic, briefly outline a potential research project that could be shaped into a dissertation. Doctoral students at any stage are welcome to apply to the consortium, and the consortium is especially beneficial for students who are in the dissertation proposal development stage or later. As part of the Doctoral Consortium, students will have an opportunity to present their research proposals or current projects to faculty members in the field.

To submit a proposal, you may e-mail your abstract to both of the PNP Doctoral Consortium Co-Chairs using the e-mail addresses below. Be sure to include a title on your proposal along with your name, school, and preferred e-mail and phone number.

If accepted, submitting your abstract to the Doctoral Consortium Co-Chairs by February 3rd will ensure that your name appears in the conference program as a participant in the Doctoral Consortium. Students accepted to participate in the Consortium must register for the conference. However, there is no additional charge to participate in the Doctoral Consortium. Slots in the Doctoral Consortium are allocated on a first-come, first-serve basis.

Masini Award

The **Carlo Masini Award** for outstanding scholarship in the fields of public and nonprofit management will be presented to the best paper from across the entire Academy of Management which examines the behavior of public and/or nonprofit organizations. Winners of the award will receive a \$2000 prize in recognition of their achievement. This award is created by IPAS (Institute for Public and Health Administration) – Bocconi University of Milan in recognition the lifetime achievements of Prof. Carlo Masini to the field of public management.

How the Award Works:

Eligibility: Only papers that have been submitted to and accepted by the Public and Non-profit Division will be eligible for the award. All accepted papers are eligible including those that have been nominated or selected for other awards given by the PNP division.

Selection: A panel of international scholars from public and non-profit management will constitute a selection committee which will be responsible for making the award. The Chair of the selection committee will review the pool of accepted papers in conjunction with the PNP program chair and develop a short list of nominated papers for consideration by the selection committee. The selection committee will review papers on the basis of the overall creativity and innovativeness of the research as well as the significance of the contribution to PNP scholarship.

Recognition: The winner of the Masini Award will be recognized at the business meeting of the Public and Nonprofit Division. Nominated papers will also be invited to participate in a discussion of their work in the Masini Symposium.

Charles H. Levine Award for Best Conference Paper

Each year, the Division presents the Charles H. Levine Award for Best Conference Paper, sponsored generously by Routledge, to the author (or authors) of the best paper presented at the annual Conference. The winning author(s) will be announced in the Conference program and will receive a plaque recognizing the award during the Public and Nonprofit Division's business meeting at the 2012 Academy of Management conference, as well as a gift certificate for books published by Routledge. All papers submitted to the division for consideration at the annual conference are eligible for the award. The award selection is based on the evaluations received from reviewers of conference papers submitted to the Division.

Best Conference Paper by A Doctoral Student

Each year, the Division presents an Award for the Best Conference Paper by a Doctoral Student, sponsored generously by Sage Publications, to the author of the best paper presented at the annual Conference by a doctoral student. All papers submitted to the division for consideration at the annual conference, whose author identifies herself or himself as a doctoral student, are eligible for the award. The award selection is based on the evaluations received from reviewers of conference papers submitted to the Division.

The winner will be announced in the Conference program and will receive a plaque recognizing the award during the Public and Nonprofit Division's business meeting at the 2012 Academy of Management conference in Boston, as well as a gift certificate for books from Sage Publications.

Call for Abstracts: 8TH ANNUAL NYU-Stern CONFERENCE ON SOCIAL ENTREPRENEURSHIP November 2-4, 2011

Our annual NYU-Stern Conference on Social Entrepreneurship is a three-day conference dedicated to the ongoing development of theory and research on social entrepreneurship and its impact on global communities. The aim of the conference is to bring together scholars in social entrepreneurship to discuss emerging concepts and themes in social entrepreneurship research.

Conference Topics and Discussions

While contributions can represent a variety of viewpoints, perspectives or approaches, research and works that address persistent issues or provide new approaches and solutions are particularly welcome. Abstracts will be selected and authors will be notified and invited by September 1st, 2011 to submit a full paper due on Saturday, October 15th, 2011. The Satter Best Paper Award (\$5,000) will be granted for the best research paper presented at the conference.
